

# Facility Plans – Past Work

- Began in 2002 with comprehensive Feasibility Facility Report
- **Community and Committees Involved**
- Established Long-Term understanding for Community & School Boards
- Protect Facility Assets with Fiscal Responsibility
- Maximize opportunities when presented for major initiatives; New High School in 2009 and Remodel New Middle School
- Refinanced new HS bonds to a lower interest rate with the same terms to prepare for future building needs with no additional tax rate impact





# Major Needs & Rationale

# New Elementary for Ridge View ES (Built 1955)

- □ Improve student learning environment
- □ Manage district enrollments and capacities
- Continue long-term Facility Asset Planning

## **New Swimming Pool for Hobart High School**

- Location of new pool at HHS for increased safety for traveling students – all athletics/fitness on one campus!
- Correct the inequity previously done by State when they eliminated the pool from the new HS building project before they would approve construction
- Community asset and public use





## **Facility Review: Ridge View Elementary**

#### Building Maintenance Needs:

Exterior Stairs and Railing Replacement

**Nurse Station Inadequate** 

**Kitchen Upgrades** 

**Exterior Door Replacement** 

**Roof Replacement** 

**Brick Replacement at Gym** 

Boiler and Pump Replacement

Upgrade Sewage Ejector System

**Electrical System Inadequate** 

#### Building ADA Compliance Needs:

Build Four Classrooms at Main Level to Overcome ADA Non-Compliance at Lower Level (3 classrooms on the lower level and no access but stairs)

Build Gym Addition to Separate the Cafeteria From the Gym

Ensure all District Students Receive Equal Facilities

#### **Building Capacity:**

Students who eat breakfast cannot all fit in the cafeteria and have to wait for available seat

Inclement weather – there is no place to hold students on arrival due to breakfast program

Shuttle extra students to Joan Martin and Liberty when student capacity is reached

Students and Families cannot fit in the cafeteria/gym for one event

Blow circuit breakers often






### Financial Investment Analysis and Value of and to Existing Building

### Ridge View Elementary

- What could we do?
  - Limitations for additions
  - Site Restrictions with Boundary Lines
  - Elevations issues with 20ft difference between lower and upper floors
- What would Ridge View gain?
  - 1 extra classroom by making building ADA compliant
  - Separate gym and cafeteria
- Are the costs of repairs and additions worth the value of the existing building?
  - Costs and additions are approximately 3.5 to 4 times the value of the building



#### **Considerations**

- There are approximately 310 students at Ridge View
- There are approximately 180 Mundell area students attending Joan Martin that are bussed
- Community assets with park settings
- Right size play areas
- Safe and efficient travel patterns



# **New Elementary Provides Other Solutions**

- New 69,500 SF/ 550 Student Elementary School
- Accommodates Student and Staff Needs from Ridge View Elementary
- Reduction of transportation services needed by 2-3 busses
  - Currently only 22 walkers at Ridge View
  - Mundell neighborhood within walking distance
- Accommodates Approximately 180 Students from Joan Martin – Mundell neighborhood back to Mundell site
- Could absorb future building of homes and additional areas of growth in the city




- **Joan Martin Elementary** 
  - Core Lunch Facilities Inadequate for Building's Population (at original design the café size was cut due to budget)
- □ Kitchen/Serving/Dining
  - 60% Student Lunch Participation Due to Congestion
  - Approximately 180 Students bussed from Mundell Area to Martin
    - District Goal to Allow Students More Time to Eat

# **Hobart HS New Swimming Pool**

#### **Hobart HS Site**

#### **Considerations**

- Build a pool as intended in the original New HS Project before the state eliminated it (the building has the rough-ins ready to go from the original construction)
- Correct the elimination of lockers when the pool was removed from the new HS construction project
- Provide safety by eliminating constant travel to Middle School for High School Students
- Swimming is a life skill for wellness needed by ALL students beyond MS level instruction
- Practicing in a pool after game days for all athletes provides recovery and conditioning
- Providing a pool at the HS adds physical therapy and rehabilitation for student athletes by athletic trainer
- □ Community hub for activity


#### EST. \$41,210,000 BOND ISSUE - NOVEMBER 2017 REFERENDUM

# **Estimated Budget – Bond Issue Capitalized Interest**, \$800,000 Costs of Issuance, \$410,000 **Project Costs**, \$40,000,000





#### EST. \$41,210,000 BOND ISSUE - NOVEMBER 2017 REFERENDUM



Estimated Tax Bill Change Due To Exempt Debt Roll-Off

\* Assumes only the impact of the School City of Hobart's exempt debt rolling to non-exempt and a maximum borrowing with no rate increase over the 2016 Debt Service Rate (utilizing the savings from the 2016 bond refunding).





# The Question on the ballot for November 7, 2017 Referendum

#### **PROJECT REFERENDUM**

□ Shall the School City of Hobart issue bonds or enter into a lease to finance the 2018 Safety, Efficiency, Technology, Renovation and Construction Project which consists of restoration, repair and renovation of Hobart High School, Hobart Middle School, Liberty Elementary School, The Early Learning Center at George Earle Elementary, Ridge View Elementary School and Joan Martin Elementary School and the construction of a new elementary school and a pool at Hobart High School, and which is estimated to cost not more than \$41,210,000 and is estimated to increase the property tax rate for debt service by a maximum of \$0.80 per \$100 of assessed valuation?

# A Fall 2017 Capital Referendum

SCOH could do a Capital Referendum for a new elementary school and pool – no tax rate impact Fall 2017

# □ <u>Advantages</u> of doing these projects in the Fall of 2017

- No tax rate increase in 2017
- Low interest rates for construction
- Avoid future construction cost inflation
- Generational impact on the community
